



THE VISION ASM PERSPECTIVE

 "A mining sector that harnesses the potential of ASM to stimulate local/national entrepreneurship, improve livelihoods ad advance integrated rural social and economic development"

ACTUALISATION OF VISION FOR ASM

- Review of the Africa's ASM Regimes: Policies, laws, regulations, standards and practices
- Development of policy guidelines and standards
- Alignment of initiatives to the Vision
- Mechanisms for delivery:
 - The role of governments
 - The role of development partners
 - A role for CASM-Africa?

MECHANISMS FOR DELIVERY

Role of governments

Providing national and regional frameworks for all initiatives

Role of development partners

Providing support for fit into global development frameworks

Role of CASM-Africa

- Raising the profile of ASM in Africa
- Development of policy guidelines and standards for regional frameworks (that can be cascaded into national implementation frameworks)

CASM-AFRICA STRATEGY

Constraints

Opportunities



CONSTRAINTS

- Poorly articulated strategy
- Lack of a strategic focus
- Poorly resourced
- Poorly structured
- Ad hoc implementation of interventions by development practitioners

OPPORTUNITIES

Broad network of African practitioners

- Government officials, development practitioners, donors, ASM, community associations
- Recognition by regional structures, e.g. SADC, UNECA, AU/(AMP)
- Donor support for ASM development
 - Implementation of interventions within the framework of the Africa Mining Vision
- Link with other initiatives, e.g. ISG, regional strategic activities like ICGLR, EITI, etc.

AREA OF FOCUS

High level policy work

ASM Regimes

- Review the regimes
- Develop of policy guidelines and standards for development of ASM Regimes
- Develop policy guidelines and standards for specific theme areas, e.g.
 - Gender mainstreaming
 - Child labour

FRAMEWORK FOR ACTION

- Build a "Committed Core" Group
- Develop working groups (volunteers) for each area of focus (ISG model)
- Mainstream the Review of ASM Regimes into the AU, through the ISG
- Self-resourced participation in national, regional, AU and international forums
